## The Council may call an EXECUTIVE SESSION pursuant to NMSA 1978 Section 10-15-I(H) for the following reasons:

- 1. meetings pertaining to **issuance**, **suspension**, **renewal or revocation of a license**, except that a hearing at which evidence is offered or rebutted shall be open;
- 2. **limited personnel matters** means the discussion of hiring, promotion, demotion, dismissal, assignment or resignation of or the investigation or consideration of complaints orcharges against any individual public employee;
- 3. deliberations by a public body in connection with an administrative adjudicatory proceeding;
- 4. the **discussion of personally identifiable information about any individual student**, unless the student or the student's parent or guardian request otherwise;
- 5. meetings for the **discussion of bargaining strategy preliminary to collective bargaining negotiations** between the policymaking body and a bargaining unit representing the employees of that policymaking body and collective bargaining sessions at which the policymaking body and the representatives of the collective bargaining unit are present;
- 6. that portion of meetings at which a decision concerning purchases in an amount exceeding \$2,500 that can be made only from one source and that portion of meetings at which the contents of competitive sealed proposals solicited pursuant to the Procurement Code (13-1- 28 NMSA 1978) are discussed during the contract negotiation process. The actual approval of purchase of the item or final action regarding the selection of a contractor shall be made in an open meeting;
- 7. meetings subject to the **attorney-client privilege pertaining to threatened or pending litigation** in which the public body is or may become a participant;
- 8. meetings for the discussion of the purchase, acquisition or disposal of real property or water rights by the public body.

Note: NMSA 1978 Section I 0-15-l(H) Exceptions (4) relating to students, (9) relating to public hospitals, and (I 0) relating to the gaming control board were not listed above since they do not apply to the Town of Silver City.

- **6. APPROVAL OF MINUTES** Regular Meeting on January 25, 2022. <u>Councilor Farmer moved to approve the Minutes of the Regular Council Meeting of the Town of Silver City of January 25, 2022. Councilor Ray seconded. <u>Motion carried.</u></u>

Mr. Sprowl feels that a person should not be stopped if not wearing a mask if it is not law.
- **8. REPORTS** Chief of Police Freddie Portillo handed out graphs pertaining to Crime and Crash Data from 2021 and previous four years. Chief of Police Portillo stated that at the beginning of the year his

officers and him work on ways to prevent crime and crashes in the community. Chief of Police Portillo wanted to thank the Town management for their continued support and wanted to recognize all the members of the Police Department for the continued effort keeping our community safe.

#### 11. NEW BUSINESS

A. APPROVAL / DISAPPROVAL OF NOTICE OF INTENT TO ADOPT AN ORDINANCE 1309, AMENDING CHAPTER 32 (NUISANCES), ARTICLE 1 (IN GENERAL), SECTIONS 32-1 THROUGH 32-32, ARTICLE II (ABANDONED VEHICLES), SECTIONS 32-33 THROUGH 32-49, ARTICLE III (RESERVED), SECTIONS 32-50 THROUGH 32-64, PROVIDING DEFINITIONS AND EXAMPLES; PROVIDING FOR ABATEMENT; AND SPECIFYING LEGAL PROCESS.

Town Attorney Jim Reynolds explained the amendments to Ordinance 1309 allowing Code Enforcement to deal with nuisance in two ways. First, is to file a criminal complaint in Municipal Court where the Municipal Judge can fine the violator if there is a nuisance, which will be for minor violations. The second option is for major violations, the Code Enforcement Officer can cite the violator with a Notice to Abate giving the violator to clean up the nuisance in a reasonable amount of time specified in the Ordinance. If the violator does not clean up the nuisance in the allotted time the City can clean it up. How ever the violator has a right to a hearing in front of the Town Council, which will be the Town Councils responsibility and duty if a nuisance exits that when and how it's going to be cleaned up and who will clean it up. Attorney Reynolds stated that the current Ordinance did not specify in detail which now it is in section 32.3. Attorney Reynolds also stated that there are illustrations in the Ordinance that what constitutes a nuisance taken verbatim from Deming and Las Cruces Ordinances. It provides a person with the knowledge if what they are doing constitutes a nuisance. Attorney Reynolds advised the Town to use a reasonable standard of common sense to interpret the illustrations in the Ordinance.

Councilor Prince read a hand out to the Councilors on his concerns. Councilor Prince asked if the Council could wait for a final adoption until May 3, 2022 to review all concerns. Councilor Cano opposed to wait until May 2, 2022 to vote on the Ordinance. Normally 30 days for public input is enough time. It does not take three months for the public to give us input so she did not feel that the Council should take three months to give their input to approve the Ordinance. Mayor Ladner asked Attorney Reynolds if he would answer the concerns Councilor Prince pointed out. Alex Brown advised Mayor Ladner that Mr. Reynolds and James Marshall worked on the Ordinance together and Mr. Marshall would answer the questions. Mr. Marshall stated that he reconciled both the proposed NOI and current Ordinance and they both were close to both Deming and Las Cruces Ordinances that Mr. Reynolds used to draft the amended ordinance. Mr. Marshall answered each concern that Councilor Prince spoke about in his comments. Councilor Ray moved to approve NOTICE OF INTENT TO ADOPT AN ORDINANCE 1309, AMENDING CHAPTER 32 (NUISANCES), ARTICLE 1 (IN GENERAL), SECTIONS 32-1 THROUGH 32-32, ARTICLE II (ABANDONED VEHICLES), SECTIONS 32-33 THROUGH 32-49, ARTICLE III (RESERVED), SECTIONS 32-50 THROUGH 32-64. PROVIDING DEFINITIONS AND EXAMPLES; PROVIDING FOR ABATEMENT; AND SPECIFYING LEGAL PROCESS. Seconded by Councilor Cano. Mayor asked for a roll call vote. Councilor Farmer voted aye; Councilor Prince voted aye; Councilor Ray voted aye; and Councilor Cano voted aye. Motion carried.
